A. Recognize New Board Members
Our new members were not present, so this was postponed.

- B. Financial Management Policies & Procedures
 Bryan McDermott made a motion to approve the existing
 Financial Management Policies & Procedures. Delroy Ziadie
 seconded the motion. The motion was amended to cover just the
 next month, to give the new Executive Director the opportunity to
 suggest changes; the Board will revisit this issue at their next
 meeting. The amended motion carries unopposed.
- C. 2014 Board Meeting Schedule
 The board amended, then approved the meeting schedule for 2014.
- D. Premier League Committee Creation
 The Board discussed the best way to have fair representation on
 the premier league committee. Bryan McDermott made a motion
 to appoint the DOC from each affiliate with a team playing in the
 Premier League to be a member of the Premier League Selection
 committee. Delroy Ziadie seconded the motion. The motion
 carries unopposed.
- E. Vacant Board Positions

 Peggy Pruitt was approved to fill the unexpired term of Director of

 Adult Competition. The Director-Player Athlete position she
 vacates will be filled by Aly Wade.
- F. Approval of Committee Appointments
 Bryan McDermott made a **motion** to approve the committee appointments as listed. Delroy Ziadie **seconded** the motion. The **motion carries, with none** opposed.
- G. Procedure for Funding Proposals
 The Executive Director asked for the Board's direction in his search for additional funding: how involved does the Board wish to be?
 The President expressed full confidence in the Executive Director, and gave him permission to move forward on applications for grants and other funding without the need to involve the Board directly in the process.
- H. Update from Executive Director The Executive Director reported that the condo association is in the process of getting an energy audit and quotes for a new HVAC system. As of the end of January, we have made 58% of budgeted expenses—this is right on target—and have taken in 67% of budgeted revenue. Publix continues to support Georgia Soccer, and we are planning an event with the Latin-American Association. We are planning a membership drive and other events for the World Cup.
- I. Increase our facebook fans
 The President reported that he had invited his friends to join our

facebook page, and challenged others to do the same.

J. US Youth Soccer has ruled that the Region acted within its rules that were in place when it overrode Georgia's fourth-place team selection, so their appeal has been denied.
