



Fall 2021 Registration and Credentials Report February 5, 2022

SUMMARY OF ACTIVITIES AND ACHIEVEMENTS

1. Fall 2021 registration results (see-attached report) are as follows:
 - a. 9 active adult programs – 2,888 reported adult players.
 - b. 74 youth member affiliates – 20,537 reported recreational players and 10,366 reported select players for a total of 30,903 for the Fall 2021 season.
2. Votes allowed per affiliate for the Annual General Meeting are as follows: Youth Members with 50-499 players – 1 vote, Youth Members with 500-999 players – 2 votes, Youth Members with 1000-1499 players, - 3 votes, Youth Members with 1500 + players – 4 votes. Adult Members with 25-99 players – 1 vote, Adult Members with 100-250 players – 2 votes, Adult Members with 251-400 players – 3 votes, Adult Members with 401 or more players – 4 votes. Member Affiliates who have outstanding financials or a non-recognizable (minimal number of registrations) membership will not be credentialed to vote. Votes eligible to be cast by Life Members shall not be counted in determining the number required for a quorum. These items are reflected on the attached report.
3. Based on the Fall 2021 season registrations of all member affiliates in good standing, Life Member's and Board of Director's votes, there are 226 eligible votes available for the Georgia Soccer - AGM. For adult council business, there are 19 eligible votes available and for youth council business, there are 94 eligible votes available. There are 10 eligible Board of Directors votes, and 28 eligible Life Member votes.
4. For the GSSA Council meeting, the voting shall be weighted based on the "Eligible Votes." The total votes present shall be the Authorized Votes. 8.5.2 The weighting of the Eligible GSSA vote shall be as follows Youth Council: 50%, Adult Council: 50%, Life Members: 1 vote for each member present, Board of Directors: 1 vote for each member present. The council multiplier used for the general session is 4.9 for adult affiliates. The weighted vote for the adult delegates for business at the GSSA council meeting is reflected on the attached. If vote counts are not even, a club or clubs are randomly selected to have 1 additional vote added or subtracted to their total GSSA vote.
5. It is recommended that the member affiliates listed on the attached report, **showing votes available**, be approved by this body as members in good standing and entitled to full participation in this Annual General Meeting, except the members listed below.

Outstanding financial obligation – Athens United, Georgia Express, Kennesaw City, Olympic Atlanta, Soccer in the Streets, Toluca, Upson, and Roswell Adult Men.

No recognizable membership – Augusta, Champions United, Franklin County P&R, Newtown Rec, Peachtree Ridge Youth, and Sacred Heart.
