



## Fall 2025 Registration and Credentials Report AGM – January 31, 2026

### SUMMARY OF ACTIVITIES

1. The Fall 2025 season registration results (see attached report) are as follows:
  - a. 9 adult member affiliates. 5 having active membership.
    1. 1,985 reported adult players.
  - b. 74 youth member affiliates.
    1. 15,225 reported recreational players and 8,984 reported select players for a total of 24,209 players.
2. Votes allowed per affiliate for the Annual General Meeting are as follows: Youth Members with 50-499 players – 1 vote, Youth Members with 500-999 players – 2 votes, Youth Members with 1000-1499 players, - 3 votes, Youth Members with 1500 + players – 4 votes. Adult Members with 25-99 players – 1 vote, Adult Members with 100-250 players – 2 votes, Adult Members with 251-400 players – 3 votes, Adult Members with 401 or more players – 4 votes.
3. Based on the seasonal registrations of all member affiliates in good standing, Life Member's and Board of Director's votes, there are 183 eligible votes available for the Georgia Soccer - AGM. For adult council business, there are 16 eligible votes available and for youth council business, there are 73 eligible votes available. There are 11 eligible Board of Directors votes, and 26 eligible Life Member votes.
4. The voting shall be weighted based on the "Eligible Votes." The total votes present shall be the Authorized Votes. 8.5.2 The weighting of the Eligible GSSA vote shall be as follows Youth Council: 50%, Adult Council: 50%, Life Members: 1 vote for each member present, Board of Directors: 1 vote for each member present. Life Members shall not be counted in determining the number required for a quorum. The council multiplier used for the general session is 4.4375 for adult affiliates. The weighted vote for the adult delegates for business at the Georgia Soccer SAGM is reflected in the attached report.
5. It is recommended that the member affiliates listed in the attached report and **showing votes available** be approved by this body as members in good standing and entitled to full participation in this Annual General Meeting, except the following:

**Unidentified Membership** – Legacy Park, Peachtree Ridge, Soccer Sidekicks, Vinotinto Academy, Georgia Piedmont Y, CMH Soccer, Thomas Area Soccer, Sacred Heart, Southern Cross, and Troup County Lions. Columbus Adult, Georgia Athletic, Roswell, and Toombs County.

**Financials** – CH4 Soccer Academy, CMH Soccer Club, Grow Soccer Evolutions, Henry County, Hinesville, Oconee Futbol, Pike County, UFA South GA, Upson SA, and Warriors Futbol.
